Coming off another successful ENCATC Annual Conference this year held in Lecce, Italy from 21-23 October, ENCATC is already working on the implementation of our rich programme of upcoming activities to take place this month in Europe and Asia. Get your agendas ready!

Responding the desires and needs of our members and followers, in November ENCATC is offering three educational opportunities on two continents and an opportunity to celebrate the excellence of young research talent.

First, from 13-15 November in Taipei, ENCATC will be holding its 5th ENCATC and 1st TACPS Academy on "International Cultural Relations: New Initiatives in Taiwan, East Asia and Europe". After Bristol we will be travelling south to Barcelona for the 3<sup>rd</sup> ENCATC International Study Tour from 23-25 November. Following previous successful tours in New York and Shanghai, ENCATC is proud to bring this popular initiative to Europe for our members and followers to meet leading cultural managers and visit the most interesting arts and heritage institutions in this beautiful city. Organised alongside the Catalan Festival Conference, the main topics this year are audience development, cultural leadership, and new business models.

To conclude the events of this month in celebration, ENCATC will be hosting the Ceremony of the 2<sup>nd</sup> ENCATC Research Award on Cultural Policy and Cultural Management in Brussels on the evening of 25 November. #### Meet three of ENCATC's newest members!

#### The University of Regina, Canada

The University of Regina is home to 10 faculties and 25 academic departments which have established reputations for excellence innovative programs leading to bachelor's, master's, and doctoral degrees. In Fall 2014, approximately 14,000 full-time and part-time undergraduate and graduate students enrolled at the University and our three federated colleges: Campion College, First Nations University of Canada, and Luther College. The process of founding Kultura Nova, extending over several years, included representatives of civil society organisations, different state administration bodies, public government bodies and experts. #### 16 September 2015 // Brussels, Belgium

ENCATC Secretary General, GiannaLia Cogliandro Beyens, attended the presentation of the 'Cultural Heritage Counts for Europe' (CHCFE) project results to Members of the European Parliament. The event was held during the meeting of the Intergroup on European tourism development, cultural heritage, Ways of St. James and other European cultural routes. ENCATC was one of the six partner organisations of the CHCFE project.

#### 17-18 September 2015 // Ispra, Italy

ENCATC was invited to share expertise at the "A pilot Cultural and Creative City Index - Validation workshop" organised by the European Commission's Joint Research Centre. On 23 October in Lecce, Italy the 23<sup>rd</sup> ENCATC General Assembly gathered representatives of ENCATC member institutions from Europe and beyond to elect a new board for a two-year term (2015–2017). The newly elected board members started their term on October 23, 2015.

ENCATC members renewed their trust in four members by re-electing: Maria Bäck from Arcada University of Applied Sciences, Finland; Manuèle Debrinay-Rizos from Aix-Marseille University, France; Marcin Poprawski from Adam Mickiewicz University in Poznan, Poland; and Annick Schramme from the University of Antwerp/ Antwerp Management School, Belgium.

To replace ENCATC Board members whose mandate had expired, ENCATC members elected three new representatives from its full membership: Ana Gaio from City University London, United Kingdom; Francesca Imperiale from the University of Salento, Italy; and Marilena Vecco from Erasmus University Rotterdam, the Netherlands. In addition, this year, to stress the importance of the link between academia, research and practice a representative from the associate membership was elected for the second time in the ENCATC history: Bernd Fesel from the european centre for creative economy (e.c.c.e.), Germany.

Following two years of successful leadership, board members re-elected Annick Schramme as ENCATC President.

At the occasion of the General Assembly in Lecce, the Board also decided to co-opt **Antonia Silvaggi** from Melting Pro in Italy for the completion of particular projects.

"The ENCATC Board is a working board and these newly elected members will play a vital role by bringing new perspectives that are critical in ensuring ENCATC remains the leader of excellence in cultural policy and management. I am convinced that they are all highly driven to serve the diverse needs of ENCATC's membership base reaching over 40 countries. Moreover, the new board is eager to continue and build upon the excellent work and achievements ENCATC has accomplished over the past 23 years. #### Interview with Sara Borrelli

New ENCATC member from Explora the Children's Museum of Rome in Italy

Sara Borrelli has been working at the Explora the Children's Museum of Rome since 2005. This dynamic and engaging organization became an associate member of ENCATC in 2015. As project manager of national and European projects Sara identifies new public Grants, builds partnerships with other museums and cultural institutions, writes proposals for public agencies, manages the implementation of financed projects such as cultural events, educational workshops and interactive exhibitions related to science, the environment, cultural heritage and new technologies. These activities are aimed to families, schools and children. She also promotes Explora the Children's Museum of Rome at public conferences to disseminate its experiences and best practices and to enrich its network.



#### **ENCATC: Why did you join ENCATC?**

# 23<sup>rd</sup> ENCATC Annual Conference "The Ecology of Culture" 21-23 October 2015 in Lecce, Italy

A hot theme and culturally rich location attracts to Lecce



For three days in beautiful Lecce, Italy ENCATC was joined by 185 participants from 30 countries for its 23<sup>rd</sup> Annual Conference "The Ecology of Culture: Community Engagement, Co-creation, Cross Fertilization". Among the participants were leading academics and researchers, influential experts, experienced educators and trainers, cultural managers, policy makers, artists, and students.

Why did so many people travel from across the globe to participate in our conference? The strong participation numbers this year attest to the relevance of our theme "The Ecology of Culture". Seeing culture as an ecology, rather than only as an economy, is helpful to stimulate discussion on the multiple values culture creates, rather than focusing only on financial or social ones. To bring us new perspectives and stimulate reflection on the topic, we were honoured to have with us in Lecce our keynote speaker, John Holden, an Associate at the think tank Demos, where he was Head of Culture for 8 years. He is also a visiting Professor at City University, London, and an Honorary Professor at the University of Hong Kong. In early 2015, John Holden published a report, The Ecology of Culture. During his research he found that culture is an organism not a mechanism, and that careers, ideas, money, product and content move around between the funded, commercial, and homemade/amateur parts of the overall cultural world in such a way that those funding categories cannot be disentangled.

Holden's research and expertise on the ecology of culture concept helped us to see our position in relation to culture. "As with the natural ecosystem, the cultural ecosystem is not separate from us, or related to us, but rather we are embedded in it — it makes us, at the same time as we make it. Culture is always work-in-progress, and always a social process. In addition to that, an ecology is non-hierarchical: all the parts are required to make the whole, and in that sense, all the parts are equal. Treating culture as an ecology brings the qualitative into consideration as much as the quantitative, and treating culture as an ecology is also congruent with cultural value approaches that

take into account a wide range of non-monetary values. By applying ecological metaphors such as emergence, interdependence, networks, and convergence to culture, we can gain new understandings about how culture works, and these understandings in turn help with policy formulation and implementation," said professor Holden.

The list of ecological metaphors above can be expanded to include growth, evolution, systemic fragility, life cycles, and webs. These can be applied to the world of culture, and they illuminate the way that culture functions.

The cultural ecosystem metaphor was also used to shed light on new forms of cultural production, cocreation. cross-fertilization and community participation in a local context which were sub themes of our conference. Local communities are crucial places where cultural activity is rooted and exposed to different conditions for growth or death. Co-creation in terms of value creation, convergent art, co-production, cooperative learning, and collective funding is from this perspective very relevant and closely linked to different ways of community participation. Cross-fertilization implies establishing links between culture and economy, culture and society, local and global and technology as well, telling us how these links transform behaviour, fertilize knowledge, allow for creativity, etc. The use of an ecological approach by researchers and policy makers is a way of assessing multidimensional relations of different cultural actors and other sectors.

The notion of ecology and the biological analogies set up a set of questions for us to ask in Lecce such as: what conditions bring a form of culture into being? How is that form of culture then sustained? What threatens its existence? How can it be nurtured to grow to its full potential? These questions, and others like them help artists, administrators and policymakers to better understand both the state of their own specific cultural ecology (for example in a town or region, or across an art form) and what actions they could take to maximise the health of the ecosystem. It also emphasises their limited role — no-one can

control an ecology, although they can affect it in benign or destructive ways.

How did we further breakdown new ways of understanding the ecology of culture? One was to think about culture in terms of a creative cycle: new cultural events and forms feeding on the past, making something new, becoming established, and then being re-worked in their turn. A second was about tracing the webs and networks of connection at a local or an art form level – this helps show how robust and productive the cultural ecology is.

In all of its complexities, how can one find his or her place in the ecology of culture? Holden's work brought him to distinguish four essential roles that have to be undertaken within any cultural ecology. These roles are: Guardians, who look after the culture of the past; Platforms, that provide the places and spaces for the culture of the present; Connectors, who make things happen and bring together other parts of the system; and Nomads all of us who, as artists or audiences, interact with the other three roles. In each case, these roles can be carried out by funded, commercial or unpaid amateur people or organisations. For instance Disney, the V&A, and volunteer heritage groups act as Guardians; and Connectors range from Local Authority arts officers to commercial film producers. Some organisations carry out multiple roles, but most only one.


Ecologies are dynamic, productive and complex. They have the potential to lead to new taxonomies, connections, visualizations, and a clearer picture of the proper characteristics of a particular cultural field. For these reasons and more, "The Ecology of Culture" made for a rich debate during our time together in Lecce.

#### A RICH PROGRAMME FOR AN INTERNATIONAL AUDIENCE

ENCATC's 23<sup>rd</sup> Annual Conference began on Wednesday, 21 October with our welcome and official opening. This first plenary session kicked-off this major international event at the breath-taking and historic Teatro Paisiello.

To set the context, we started with an introduction from the University of Salento followed by our keynote presentation on "The Ecology of Culture". Next, our international panel of experts reacted and shared their different perspectives and ideas on the conference's theme for a lively discussion. To conclude the first day, conference participants were invited to a reception with an artistic programme showcasing local talent and culture.

The second day began with part one of the 6<sup>th</sup> Annual ENCATC Research Session. With a record number of submissions in 2015 (97), for the first time this annual gathering of leading academics, researchers and practitioners had to

be divided into two parts, each made up of multiple parallel sessions dedicated to sharing the latest research trends and developments happening in the fields of cultural policy and cultural management. 60 papers from 25 countries were selected by the Research Session's Scientific Committee to be presented in Lecce. To contribute to advancing the careers of the Research Session presenters, ENCATC also invested in the publication of an e-book *The Ecology of Culture: Community Engagement, Co-creation and Cross Fertilization* (see page 16 for more information).

After a networking lunch, conference attendees participated in one of five parallel seminars and study visits. Co-produced by the University of Salento, each seminar and its corresponding study visit programme had been specially designed to reflect on the conference theme within the

frameworks of ENCATC's different Thematic Areas. Renowned academics, researchers, experts, and cultural operators shared case studies, contributed to group discussions, and welcomed participants to discover cultural offers unique to Lecce and the surrounding Puglia region.

That evening, ENCATC hosted a networking dinner held at the Chiostro dei Domenicani situated near Lecce's historic centre. The convent dating back to the 15<sup>th</sup> century is an elegant, refined, and picturesque setting steeped in history and tradition.

Day three of the conference started with the second part of the 6<sup>th</sup> Annual ENCATC Research Session where participants heard more presentations on relevant and innovative research conducted in cultural policy and cultural management.

Next in the programme was the **Transfer Knowledge Session** which is a learning platform to present a variety of interesting methodologies, tools, and opportunities aimed at academics, researchers, cultural operators and artists. Our Transfer Knowledge Session experts shared their know-how so participants could gain first-hand insight on Horizon 2020 research opportunities, get advice on how to write a successful European project, learn how European cultural leadership can influence and drive change within society, and understand different research and development opportunities at the European Cultural Foundation.

ENCATC was honoured to have for the third time, its American sister organisation, the Association of Arts Administration Educators (AAAE) at the conference. Over the years, the ENCATC/AAAE relationship has strengthened through ENCATC's Cross Atlantic Education Exchange (CAEE) programme that aims to reinforce and expand synergies between members of both networks on each side of the Atlantic. AAAE was closely involved in the design of the afternoon plenary session on 23 October entitled "Culture Flash: A Lightning Round of Arts Engagement Case"

**Studies"** during which academics and researchers from the United States and China shared thought-provoking examples that inspired us for our daily work.

The last plenary session of the conference was the MED Seminar focusing on "Training for cultural managers in the Mediterranean to foster cooperation and development". The training of cultural managers in the region presents a major challenge for the development of the independent cultural sector in their own countries. There are also urgent needs to support artists and establish cultural policies. Through professionalization of operators, regional international trade becomes crucial for artistic mobility as well as for the development of civil society. This seminar aimed to identify the needs and keys for successful cultural management training in MED countries as well as question the balance between the needs of public and private sectors with the training being offered.

Once more this international event brought together academics, researchers, decision makers, influential experts, practitioners and artists to make significant improvements to worldwide education in the field of cultural management and cultural policy. The ENCATC Annual Conference is the leading international platform dedicated to innovation and creative action in education where renowned academics and researchers share insights with on-the-ground practitioners and collaborate together to rethink education.

This three-day event offered a convivial environment to hear from experts, gain new knowledge, share experiences, enlarge professional networks, and internationalise careers with other participants from coming over 25 countries in Europe and beyond. Attendees were given an opportunity to collaborate, share best

Working with the prison cooperative "Made in Carcere", this programme offers a second chance to female prisoners at the Borgo San Nicola prison by providing rehabilitation services and training. Also committed to saving the environment, the motto of "Made in Carcere" is Remember the 4 "R" Recycle, Reuse, Re-source, Reduce. The women produce handbags and small accessories using only recycled materials and are supported by the services of a manager who offers training and guidance in production practices through regular meetings.

#### **ENCATC Breakfast reveals key insights for Erasmus+ 2014-2020**

ENCATC's attractive training initiative brings together busy professionals looking to get an edge on Erasmus+ project proposals



EU representatives and experts on Erasmus+ Jacqueline Pacaud and Elena Tegovska deliver an ENCATC Breakfast training to 27 participants in Brussels.

This edition of the ENCATC Breakfast training on Erasmus+ brought together 27 participants from Belgium, Germany, Italy, the Netherlands and Spain. The session brought expertise directly from EU officials running the Erasmus+ programme: Jacqueline Pacaud, Head of Sector Schools, vocational education and training, skills and adult education, and Elena Tegovska, Policy Officer for Sector Higher Education for the Erasmus+ Programme.

Understanding different funding schemes can be intimidating. Even when ready with a project idea, writing a lengthy project application can be a daunting task. With the help of experts, participants learned more about the Erasmus+ programme's objectives and challenges for the period 2014-2020. They also received a clear presentation of the different actions structuring the programme and which actions are best suited for different project proposals. It was also important to gain understanding of the key differences in the 2014-2020 programme and what these changes mean for schools and higher education, vocational education and training, and adult education sectors. Finally, to help participants prepare for their project proposals, experts went over the Do's and Don'ts of applying and how to make project proposals more competitive.

Hosted at the Spanish Embassy in Brussels, participants not only gained all of this insight from EU representatives, they also had time to share project ideas, concerns, ask questions about the best funding avenues, and meet with potential partners interested in Erasmus+.



#### **EU launches Young Talent Architecture Prize**

On 16 September, the European Commission launched the Young Talent Architecture Prize (YTAP). The new initiative aims to support young talents to build an international career. The announcement, made by Tibor Navracsics, European Commissioner for Education, Culture, Youth and Sport, came during Shaping European Cities, the opening event of the exhibition dedicated to the European Union Prize for Contemporary Architecture - Mies van der Rohe Award in Brussels. The Prize will choose winning projects based on their excellence, authenticity and innovative nature, as well as their sustainable approach. The winners will receive a financial reward and become part of the network of awarded architects of the Prize. Moreover, they will have the opportunity to travel, visit, and experience the best examples of architecture. An international jury will select the winning projects from three best Master's degree projects from Europe. The selection will be made from proposals submitted by about 50 accredited schools and universities in Europe, expanding in future editions to other geographical areas. In addition to recognizing young talent, the Prize will also acknowledge universities committed to architectural quality as a driving force for the European economy and European culture. The list of schools and universities will be made public in January 2016.

#### Europe needs to build a Digital Single Market in which the cultural sector can thrive

On 30 September in Brussels, European Commissioner for Education, Culture, Youth and Sport, Tibor Navracsics, addressed attendees at the European Broadcasting Union 17<sup>th</sup> Sports Assembly. He stressed the need for building a true Digital Single Market that will allow the European digital sector to flourish. "*My priority is to make sure that the cultural and creative sectors – including the audio-visual media industry – thrive in the digital space. In particular, I want public service broadcasters to be able to effectively fulfil their duties such as promoting culture," said the Commissioner. The Digital Market Strategy, a priority for policy makers in Brussels, has immense potential to boost Europe's cultural sector and strengthen its cultural diversity. According to the Commissioner, it will be key for policy to get four central elements right: the rules on copyright, portability, geoblocking and audio-visual services. The Commissioner also called for balance between public interest and market needs when regulating the audio-visual sector. He believes one aspect of this balance is the European "dual" system for audio-visual broadcasting - in which public service broadcasters and commercial broadcasters exist side by side and complement each other. "The environment has been profoundly changed by the digital shift. We will need to create a level-playing field between traditional broadcasters and other providers who offer similar services, such as streaming," said the Commissioner.*

#### Increasing visibility for Europe's Industrial Heritage at European Heritage Days 2015

During the month of September, Europe examined its shared past through the unique lens of its industrial heritage with more than 30 countries joining this common theme for the 2015 edition of European Heritage Days. Throughout Europe the remains of its industrial past are visible everywhere: bridges, canals and railways, many still in use today and making invaluable contributions to the economy. However, in most countries there are signs of long-gone industry − a derelict mill, a rusting machine, a brick chimney − all marking the sites of a once-thriving workplace and community. By focusing on this theme, European Heritage Days used the industrial past to tell the story of change, development and creativity and of how and where Europeans worked, the kinds of jobs and how citizens lived. More than 20 million people participated in over 50,000 heritage events across Europe, each highlighting the historic economic links Europeans share through the vast legacy of industrial heritage sites. Launched in 1985, the European Heritage Days have been organised since 1999 as a joint initiative of the European Commission and the Council of Europe. With cultural heritage also as a priority under Creative Europe, the European Heritage Days received €200,000 in support from Creative Europe and €200,000 from the Council of Europe with additional funding from national and regional backers.

#### Culture is the "hidden gem" in making Europe a stronger global actor

On 3 and 4 September 2015, the Luxembourg Presidency of the Council of the EU organised a conference in Luxembourg, entitled "Culture and development: towards a more strategic approach to cultural policies in the EU's external relations". The aim of the conference, which brought together forty European and international speakers, was to give insight into the way in which culture and development interact, and also to raise questions about the coherence of cultural policies and cooperation in development. The European Commissioner responsible for Culture, Education and Sport, Tibor Navracsics, stressed that culture was an "integral part" of the EU's work with regard to sustainable development. "We are witnessing a real paradigm shift. 'Cultural diplomacy' is moving away from merely showcasing the excellence of a country. Instead, it is becoming a process of mutual learning and 'cocreation' based on equal partnerships," he said. The Commissioner mentioned the EU is trying to develop this aspect of its foreign policy, adding that culture can facilitate dialogue and improve understanding between people in situations where terrorism threatens to divide. To conclude the conference, Luxembourg's Minister for Culture, Maggy Nagel, remarked that the debate showed the need "to put a political vision at the heart of the culture and development strategy by coming up with a European process for this topic, or on the link between culture and external relations". She also claimed "that there is a need to systematise the co-construction of strategies and programmes with partners and those who receive" development assistance.

Cultural diversity and education recognised for capacity to foster mutual understanding in Europe On 15 September in Brussels, the European Parliament's Committee on Culture and Education held a hearing to discuss the role of intercultural dialogue, cultural diversity, and education in promoting EU fundamental values. Led by the Committee's chair and MEP, Silvia Costa, this hearing brought together policy makers, decision makers, and experts in culture and education to debate ways to foster mutual understanding. Ms. Irina Bokova, Director-General of UNESCO was invited as a special guest to address the Committee on the role of UNESCO for the protection and promotion of cultural diversity. During her presentation, Ms. Bokova highlighted UNESCO's cooperation with the European Union, particularly in the fight against illicit trafficking, the protection of cultural heritage, and the response to emergency situations. "With the support of the European Union, UNESCO is working to bring education in refugee camps in Jordan, in Syria and in Iraq to support young populations, who are extremely vulnerable and easy targets of criminal groups," said the Director-General, stressing that "I have seen the impact on these programmes on the ground, these are the projects we can duplicate and scale up." Ms. Bokova's presentation was followed by leading experts and academics who discussed related topics such as the increasing importance of interreligious competence, combating intolerance and promoting diversity in education, and the role of culture responsive spatial research in higher education and professional capacity building for stronger communities.

#### EU urges for a new, more inclusive vision of education and training up to 2020

On 1 September in Brussels, a joint report published by the Commission and Member States called for making European education and training systems more socially inclusive. This report comes as part of the wider efforts to tackle radicalisation following the 2015 attacks in Paris and Copenhagen. Tibor Navracsics, EU Commissioner for Education, Culture, Youth and Sport, said: "Young Europeans are facing common challenges that need joint responses. The threat of radicalisation shows how urgently we need to improve education prospects across all our communities." The report for the implementation of the strategic framework for European cooperation in education and training (ET2020) proposes a sharper policy focus to better address these challenges. The six new priorities identified in the report include improving people's skills and employment prospects and creating open, innovative and digital learning environments, while at the same time cultivating fundamental values of equality, non-discrimination and active citizenship. "Youth Employment is a top priority for this Commission. Relevant and high-quality skills are needed more than ever to find a job today. Better cooperation in education and training will help to raise skills and competence levels to tackle skills mismatches and thus support young Europeans to successfully enter the labour market," said Marianne Thyssen, EU Commissioner for Employment, Social Affairs, Skills and Labour Mobility. Education and Training 2020 (ET 2020) is a cooperation tool for

education established in May 2009. Coordinated by the Commission, it offers Member States, EU institutions and education institutions a forum to exchange best practices, information, and advice for policy reforms.

#### EU action in education, science and research to boost our regions and cities

On 28 September in Brussels, at the 11th Conference of European Regions and Cities on "Survival strategies for Regions and Cities in Europe" the European Commission presented how EU actions and programmes are playing specific roles in fostering innovation and growth in the regions. With the EU's priority to boost economic growth and job creation, Tibor Navracsics, European Commissioner for Education, Culture, Youth and Sport, highlighted how education systems and institutions have a vital role to play: "Education equips people with what Europe's cities and regions need: knowledge, skills, and, of course, competence. And education nurtures inspiration, creativity, as well as the spirit of enterprise." He explained how different EU actions are committed to helping researchers to move and work across Europe. For example, through the Marie Sklodowska-Curie Actions long-term connections are being created between vital regional knowledge hubs in different countries. Another cited example, is the integration of the 'Knowledge Triangle' - higher education, research and innovation - through the Knowledge and Innovation Communities or KICs. The EU also has instruments that can help higher education institutions in better defining their role in regional innovation capacity and specialisation strategies. For higher education institutions to fully understand their strengths and weaknesses, the Commission, in cooperation with the OECD, has launched the self-assessment tool HEInnovate. This tool helps higher education institutions know their entrepreneurial capabilities and to see where improvements can be made.

#### Education to play a key role for ensuring integration of refugees and migrants in Europe

On 30 September in Brussels at the 30<sup>th</sup> European Students' Convention, the European Commissioner for Education, Culture, Youth and Sport, Tibor Navracsics, outlined how the EU helps Member States reform their education systems and highlighted how this cooperation is crucial in tackling a most pressing challenge: how to integrate the many refugees and migrants coming to Europe. While all levels of education play a role, the Commissioner remarked that "higher education has particular answers to offer by activating the solidarity that is one of the fundamental traits of the academic world." He cited examples of universities setting up special courses for refugee students to continue their education or ways for assessing students who arrive without documents. However, more needs to be done to pool these ideas and best practice and to share them throughout the EU so universities, teachers, and students can learn from each other and scale up successful initiatives. The Commissioner also announced plans for the European Commission to host a meeting of recognition centres from across Europe. The EU wants to support those who make it possible for students to continue their education or map their qualifications as quickly and as smoothly as possible. This meeting is only the beginning. Policy makers are also examining the best ways to step up support for asylum seekers and refugees through Erasmus+ and in policy support to governments. "We need to join forces and act together to promote tolerance, non-discrimination, fundamental freedoms and solidarity throughout the EU. And we need higher education to lead the way," concluded the Commissioner.

#### **Between the Discursive** and the Immersive 3-4 December 2015 // near Copenhagen, Denmark

Research occupies a greater and more autonomous role in the modern and contemporary art museum than ever. No longer restricted to supporting exhibitions and the collection, this type of knowledge production in the museum has become an independent, often interdisciplinary form of programming with its own curators and budget.

At the same time, a major part of the knowledge production in the twenty-first century art museum results in the creation of spectacular exhibitions and collection displays, designed to offer audiences a unique and immersive experience. Whereas didactic exhibitions and the focus of collection preservation may have previously prevailed, museums are thus increasingly embracing a synaesthetic dispositif, an experiential model of curating, to engage their public.

# Network of European Museum Organisations (NEMO)

### New European-wide study on copyright and museums

In light of recent developments in the approaches to copyright on the European level, NEMO publishes a European-wide study on the matter.

NEMO conducted a survey asking museums to help them gain an overview of 'real life' museum practice and IPR-related problems. Through the feedback from museums all over Europe, NEMO was able to produce well-supported recommendations for how copyright in Europe should be shaped to help museums, ensuring the best public access possible to their collections.

According to NEMO "Governments around Europe are re-thinking their approach to copyright, both on European as on national level. The European Commission is preparing the Digital Single Market Strategy, including a review of copyright legislative framework, will report in late 2015/early 2016."

Some key findings from the study by NEMO include:

- A need to raise awareness of the influences that copyright legislation has on the tasks and activities of museums
- Copyright licenses available to cultural heritage organisations are not adjusted to modern requirements and technical standards; in addition tariffs are frequently found to be unreasonable
- Serious challenges caused by copyright legislation for museums who wish to publish details of 20th and 21st century works online.
- Adjust legal requirements to meet the requirements of the digital age and the reasonable capacity of museums

# 2015-2016 EFFE Awards: What are the to 12 festivals in Europe?



250 festival representatives from across Europe gathered in Paris on 27 September for the announcement of the first ever EFFE Awards. An International Jury, presided over by Vincent Baudriller, Director of Théâtre Vidy in Lausanne, rewarded 12 of the most trend-setting European festivals of this year from a pool of 760 festivals from 31 countries.

The event took place at the Théâtre de la Ville as part of the Festival d'Automne à Paris' programme and is part of the EFFE – Europe for Festivals, Festivals for Europe project initiated by the European Festivals Association. The 2015-2016 awards were sponsored by the Google Cultural Institute.

The jury's decision was built on months of hard work by the hubs and experts who have pulled together a definitive list of their country's festival offerings, from world-renowned dates in the cultural calendar, to eclectic events known only to switched -on insiders.

Members of the jury said "It has been an enormous pleasure and a privilege for the jury to discover the breadth and ambition of the European festival circuit. We are glad to see that ten countries from across Europe and a wide spectrum of artistic disciplines were represented in the final selection of the 12 award winners."

The EFFE Festival Awards and Labels are the only platform to celebrate festivals from diverse genres and countries and to bring them closer to audiences across Europe. These festivals enrich the lives of citizens in communities far and wide and on top generate billions of euros for local economies across Europe each year.
